## **PROGRAM & SERVICES**

NEK-CAP, Inc. provided the following housing programs: Housing Choice Voucher Program (HCV) (Section 8); Family Self Sufficiency Program (FSS); Tenant Based Rental Assistance (TBRA); Emergency Solutions Grant (ESG); and Housing with Opportunities CoC (Continuum of Care).

Head Start programs promote child development, school readiness, and family engagement of children ages birth to five from low-income families by supporting them through a comprehensive model. Head Start is a center based program serving children ages three to five in eight counties. Early Head Start is a home based program serving children birth to three years old and prenatal mothers in nine counties.

NEK-CAP, Inc. and Kansas Food Bank collaborate to offer Filling the Gap, a summer food program, for eligible youth (to age 18) in six counties. Approximately 100 youth were served through this program.

The Family and Community Resources Department provides services for eligible families based on funding and local resources in NEK-CAP, Inc.'s sixteen county service area.






