Our ESG and SHP (CoC) homeless programs have been keeping our Family Development Advocates' busy. ESG (Emergency Solutions Grant) is working on helping five families get back into stable housing in Jackson and Nemaha Counties, and SHP (Supportive Housing Program) averages about 25 families a month in Brown, Atchison, and Marshall Counties. We have had several landlords who have expressed an interest in helping families stay in safe homes instead of being on the streets, and I am always sincerely appreciative of that. Because of their cooperation and participation in the program, we've been able to get several families into housing who may not have had that opportunity otherwise. In January, we will be doing the Point In Time count which helps to determine how many people are literally homeless at any given time in the state. Thank you to all of our community partners-landlords, churches, thrift stores, social and health care providers- who help support these families! I've been working with a family since the little guy was six weeks old. We have been through some ups and downs, but there have been two great things that have happened. Jeremiah at about 16 months started showing some signs of delay, I talked to mom and grandma about them but, they brushed it off; stating that he just needed more time. By the time he became 23 months he still wasn't meeting some key milestones, like speech. I talked to them again and they agreed to have him tested, and he was able to receive services through Tiny-K. That was going well and when he turned 34 months we started transitioning him to Special Ed but, before we got that completed the family became homeless and they missed the screening date. They were staying in and out of the local shelter, walking the streets during the day or hanging out at the Welcome Central. I worked with the family to try and find them a new home but, we kept hitting brick wall after brick wall. I was very worried about this family because it was starting to get cold and I couldn't stand to see them on the streets. Well little Jeremiah turned three with the family still homeless; they were transferred to the Head Start program but, before he started we got him screened with Special Ed and he will start receiving services. Yesterday Josh told me that the family now has a new home. I was sooooo over joyed to hear that information. I was able to see them to this point before they left my caseload but, none the less, I'm so very thankful that it all worked out for this family. I am thrilled to report that she has met this goal while attending to her newborn at home. Through continued hard work she is well on her way to earning her diploma in May!
